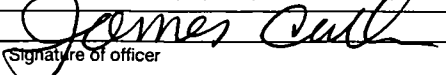

Our office equipment, electronics, and computer equipment totaled \$34,959 when new. Most of this equipment is over seven years in age.

The resulting depreciation is \$27,105 leaving our net fixed assets at the number entered.

In 2011 we purchased two new computers and a new printer that totaled \$4,063. With the change in deprecation explained earlier,

the balance sheet entry for other assets including depreciation totaled \$5,018
