series of target auto-antigens allowing the prediction of type 1

diabetes and the discovery that insulin is the primary target of islet

autoimmunity as well as collaborative trials that are now underway for

the prevention of diabetes. Every patient at the Center and their

families receive intensive education on how to best manage their

diabetes by a team of physicians, nurse educators, social workers and

dietitians whose salaries are funded by Children's Diabetes Foundation.
