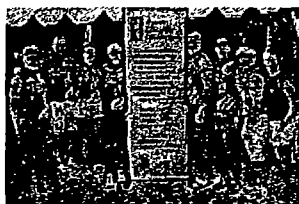
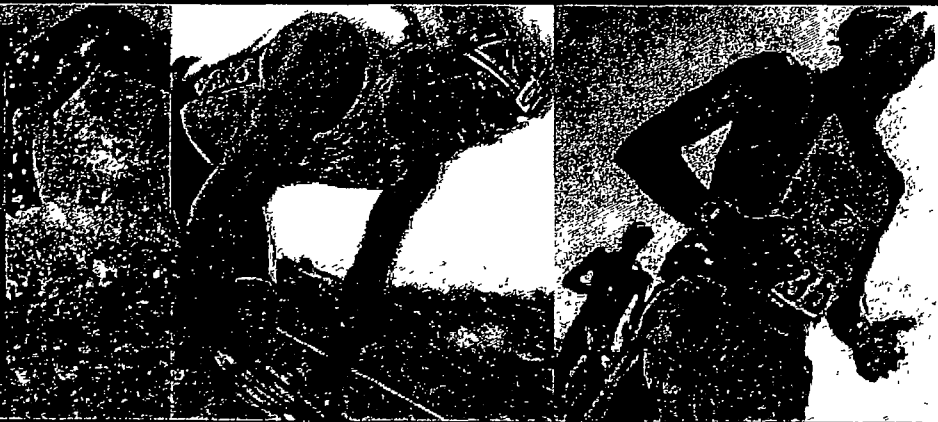

Register For the 2012 Janus Charity Challenge!

Note that athletes can accept cash, checks or credit card donations made directly to the charity, but must track and record all donations through their Participant Headquarters to qualify for the program.

Participating athletes must be registered for and race in one of the following Life Time *Race to the Toyota Cup* triathlons in 2012: Life Time Minneapolis Triathlon, Life Time Chicago Triathlon, Herbalife Los Angeles Triathlon and Toyota U.S. Open in Dallas, TX. Race entries are not provided through this program.

Step By Step Registration Process:

Step 1:

If you have not done so, register for your Life Time *Race To The Toyota Cup* Triathlon.

Step 2:

confirmed 501(c)(3) status (not pending) to be eligible for this program and this paperwork must be received before registering on line and prior to beginning your fundraising. Failure to submit the proper paperwork may result in the deletion of your fundraising site.

Step 3:

Register for the Janus Charity Challenge by selecting the link for the Lifetime Fitness race you are participating in, below. This will take you to the registration page. Do not try to register through an existing Blackbaud account.

Step 4:

Confirm you have read, understand and will adhere to all Janus Charity Challenge requirements.

Step 5:

Once your fundraising page is set up, you can make edits and update your account as often as you like by logging in to your Blackbaud Participant Headquarters.

The cutoff for fundraising is the closing time of the last day of the athlete's race Race Expo - which is usually held the day before the race (see your race's website for Expo information).
