During 2011 Team Kiwi continued to spread the Word of God in New Zealand through -ongoing training, coaching, and discipleship of the graduates of our Arrow Leadership programs, of which, we graduated over 80 in a 10-year period, -visits and evangelization at the Summerset Rest Home in Auckland -outreach to the Officers of the Salvation Army of New Zealand, with teaching, mentoring, and consulting, -extensive ministry to Crossroads Church in Palmerston North where several graduates of Team Kiwi's leadership program serve as pastors, -teaching and preaching ministry in the Hutt Valley outside of Wellington at The Kings Arms church In Africa we -taught and supported ministry to the leadership of Skills for Living, western Kenya, specifically Kisumu and Siaya, -continued ongoing training to Pastor-minister of Ugunja Church, Kenya, -carried out extensive ministry in Kenya - teaching, preaching, leading two conferences, one for Siaya Church and another for the pastors of western Kenya outside of Kisumu, -met with the director of Skills for Living, England, to set up future ministry and teaching conferences in Africa In general we organized, planned and held strategy meetings, to study and research advanced leadership training courses for New Zealand, Kenya, and United States We visited Pinnacle Church, Texas, where we taught, preached, and advised on fund-raising for Team Kiwi We also consulted and advised their missionaries going to France and Morocco We returned to our 'home church' Fellowship Bible Church in Colorado, where we taught, preached, met with elders, raised funds, and gave an accounting to the missions committee for our ministry and discussed our future
