


In rural refuge centers all over the world, we will come alongside our brothers and sisters to teach, love and journey with them – to share His peace through communities for the broken hearted.


2011 was an exciting year that produced three main activities: the continuation of service and support to our guests, an incubator project in Jamaica, and an Unbridled African Mission trip to Uganda.

In 2011, The Doud House (UnbridledACTS' first women's ministry home) served two women in their journey to wholeness and healing. During their stay, our guests received counseling, therapy, mentoring, medical assistance and support from their host family. Lonna, a current guest of The Doud house, shared her testimony to our 2011 partners:

*This past year has been very difficult for me. Though the battle to remain and face my trauma continues, [my host family] continues to show me care and support; and I am learning to receive those gifts. Daily meals and weekly meetings with them provide the opportunities for me to learn how to voice what is going on inside of me; as well as to receive truth and wisdom, often cushioned in humor. Music and art times I share with the family members lift me inside to a place of hope. Living with genuine people, who are real believers, gives me a much needed picture of how challenging, fun, and full life can and will be walking through to wholeness.*

Below are excerpts from Suzi's, a former guest of The Doud House, testimony. Her words describe how her time with UnbridledACTS impacted her and continues to encourage her.

*.. I loved living [at The Doud house] with you in the middle of my chaos in marriage. I went out there for just one weekend. (I thought, at least that was my plan. Ha, as usual, You had a different plan.) I sometimes wished I could go back and live in that incubator of growth... love... mercy... and authentic community living. What a unique time in my life. Very rewarding. It is powerful to recall the deep unconditional love I felt and received there from YOU with skin on... the skin of Cindy, Stan and the wonderful women that YOU led there to live with me. It was a painful moment in my journey though. Very painful. Deep excruciating pain. *my own wounded heart, intimate sharing and caring. It was precious time of growth and refinement*



Due to the poverty of the area and their very limited resources, the hospital only housed two incubators. With the leadership of our team, commitment of our client and God's provision, we purchased, shipped and installed nine incubators to the hospital, increasing their capacity by 400%

Board members, Dave & Beverly Harris, have continued direct involvement with Unbridled African Mission (UAM), a ministry under UnbridledACTS. In April, Beverly traveled to Uganda to work with UAM leader, Pastor Sunday, and his team. There they shared the gospel at a prison, encouraged a group of fifty widows in learning to provide for themselves and their children, and held a leadership conference with UAM members.

The excitement of the UnbridledACTS team continues to grow as we prepare our goals for the upcoming year. In 2012, we hope to build a greenhouse for The Elizabeth Community adjacent to The Doud House. The greenhouse will be a source of life-giving activity where guests can participate in the burying of seeds, caring for the seedlings and witnessing them later bear fruit or bloom. The seeds, in turn, give life back with its produce. We also believe God has provided the resources to break ground on an additional home for troubled youth in The Elizabeth Community. The idea of a second home in our first ministry community is exhilarating! Unbridled African Mission (UAM) is already underway for a successful year with plans for a March trip to Uganda. During this three-week trip, the UAM team will provide business training, discipleship and a bible conference.

Recently, we welcomed Jesie McElroy to the Unbridled Solutions team (our for-profit company) to serve UnbridledACTS. Jesie is a remarkable young woman with a passion, gift and love for the advancement of God's
