The New Mexico Acequia Association had a successful year in working toward our mission of protecting water and acequias, growing healthy food for our families and communities, honoring our cultural heritage The NMAA built upon our education and outreach work in the areas of water rights protection and agricultural revitalization through our Land and Water Program, our Food and Agriculture Program, and our Farmer-Rancher Outreach Program We also expanded work in our Organizing and Leadership Development Program with the creation of a new leadership development project entitled Escuelita de las Acequias Land and Water Program The purpose of the Land and Water Program is to protect the water rights and agricultural lands of acequia communities by building capacity for local water governance and management Our primary area of focus in this program is the Acequia Governance Project, through which NMAA does much of its workshop outreach and technical assistance Through this project, we use culturally appropriate and innovative approaches to community education and technical assistance to strengthen the capacity of acequias and community ditches to protect historic acequia water rights and to manage water for the benefit of their respective communities This includes one-on-one technical assistance and community based workshops in addition to creating educational materials that are updated annually based on lessons learned in the field In addition, the Mayordomo Project has operated as a pilot project to develop a methodology for popular education and mentorship of new Mayordomos Another emerging area of work under this program is farm succession including efforts to preserve farmland through the use of conservation easements NMAA also has an Acequia Legal Defense Fund which aids in acequia litigation Acequia Governance Project The purpose of the Acequia Governance Project is to strengthen local water management by acequias through community education and specialized technical assistance The topics that are covered in workshops and one-on-one consultations include water rights, New Mexico water law, acequia easements, elections, Open Meetings Act, Inspection of Public Records Act, the Audit Rule, and enforcement powers of acequias "On December 8, 2011, NMAA held a workshop on Acequia Easements in Santa Fe with 42 participants "NMAA presented at 33 acequia meetings throughout the state with a total of 875 participants "NMAA assisted 130 acequias throughout the state with bylaws and other governance matters "NMAA assisted 9 acequias throughout the state with completion of new bylaws "Seven Regional Governance Contracts were completed in 2011 with regional acequia associations to hold workshops and/or update their lists of acequia commissioners and parcientes The associations and dates were as follows Taos Valley Acequia Association, May 2011, Upper Hondo Water Users Association, June 2011, South Valley Regional Association of Acequias, June 2011, Santa Cruz Irrigation District, June 2011, Asociacion de las Acequias del Valle de Mora, June 2011, Rio de las Gallinas Acequia Association, June 2011, and Jemez River Basin Coalition of Acequias, June 2011 " NM Legal Aid (through its subcontract with NMAA) provided legal assistance on several topics (acequia water transfers, acequia governance issues such as bylaw reviews) to over 30 acequias Infrastructure Planning The NMAA provides assistance to acequias in creating infrastructure capital improvement plans (ICIP) A local infrastructure capital improvement plan establishes planning priorities for anticipated capital projects This process encourages acequias to plan for the development of capital improvements so that they do not find themselves in emergency situations, but can plan for, fund, and develop infrastructure at a pace that sustains their activities The plan covers a 5 year period and is developed each year It includes policy direction, funding time frames, estimated costs, justifications and the details of each specific infrastructure capital improvement project proposed, by year, over the five year period The plan includes public input In 2011, 17 ICIP's were completed with assistance from the NMAA for acequias throughout the state Mayordomo Project The purpose of the Mayordomo Project is to support the training and recruitment of individuals with the knowledge and capacity to serve as Mayordomos for acequias The Mayordomo is the person elected from within an acequia community to serve as the caretaker and manager of the ditch in terms of the irrigation schedule and ditch maintenance The Project was created as a collaboration between the New Mexico Acequia Association and the Ortiz Center for Cultural Studies to address the dwindling numbers of individuals who are willing to step in to serve in these positions Continued - See Attached Statement - Federal Supplemental Information

irrigation Older generations are not being replaced by younger generations of individuals with the knowledge needed to manage and maintain the ditches The Mayordomo Project uses participatory research in the investigation and documentation of traditional knowledge needed to operate and maintain the traditional system of irrigation used by acequias It also seeks to develop a method and program for the transmission of traditional knowledge to a new generation of Mayordomos In 2011, the participants in the project completed three major tasks 1) transcribe and analyze 27 interviews for major themes, 2) Using footage from field visits the team produced an educational video about mayordomos and mayordoma, based on field trips as well as the plticas Following a seasonal cycle, the video documents the tasks and wisdom of mayordomos 3) Develop a written mayordomo handbook based on these themes The "Handbook of Mayordoma" is an in-depth companion guide to the educational video, illustrating the method of mayordoma that was developed through the information extracted from the mayordomo interviews It's meant to serve as a practical guide for a new mayordomo or mayordoma in training Food and Agriculture Program The Food and Agriculture Program supports the work of the Sembrando Semillas Project, the purpose of which is to cultivate the next generation of farmers and ranchers through intergenerational community food projects The program also includes two collaborative efforts The NM Food and Seed Sovereignty Alliance is an acequia-Pueblo alliance established to promote the cultivation of native seeds and to protect the seeds from genetic contamination Also, NMAA partnered with the Good Food for New Mexico Families Project which supported community-based food projects in several communities Sembrando Semillas Project The NMAA supported community garden projects in three communities, each specializing in different areas in 2011 "Chamisal One mentor and one staff member worked with approximately eight youth through a season of agricultural activities They planted almost 2 acres of traditional crops, learned how to use a hoop house for season extension, and participated in traditional food processing techniques such as making jams, drying squash, and making chicos (oven roasted and dried corn) "Mora An inter-generational family gardening project held two workshops for youth and families The first workshop taught participants the traditional canning method for fruit The second workshop was a demonstration of how to cook in a horno (outdoor mud oven) "San Luis One mentor worked with up to eleven youth in an agriculture-based summer program for 8 weeks Activities included helping to build a hoop house for season extension, assisting three local farmers with their gardens, selling produce at the local farmer's market, and organizing a cheese-making workshop for the community Good Food for NM Families Initiative The NMAA and two partnering organizations (American Friends Service Committee and Farm to Table) supported seven community projects, which worked on the following "Mora and Taos Staging area for cattle processing using the Mobile Matanza "La Semilla Food Center, Anthony community food assessments by youth and formation of a youth food policy council "Agri-Cultura Network, Albuquerque developed a brand and helped determine agreements between partners for shared supplies and operating costs for a cooperative model of agriculture and retail "El Morro Valley Grower's Cooperative, Ramah researched policies for starting a grower's cooperative and started a "virtual grocery store" for residents "Red Willow, Taos built cold storage for produce and focused on expanding to a winter's market "Chamisal learned how to build a greenhouse from raw materials In addition, two convenings were held in 2011 for all project leaders for the purpose of networking, legislative training, and an opportunity for shared learning NM Food and Seed Sovereignty Alliance As a founding member and the fiscal sponsor of the NMFSSA, the NMAA hosted the 6th Annual Ow ingeh Tah Pueblos Y Semillas gathering and Seed Exchange in March 2011 with approximately 250 attendees Farmer-Rancher Outreach Program The Farmer-Rancher Outreach Program was funded in 2011 by the USDA Outreach and Socially Disadvantaged Farmers and Ranchers (OASDFR) competitive grant program NMAA staff provided technical assistance for farmers and ranchers, held workshops, and aided in and facilitated the creation of farm plans, conservation plans, and USDA applications NMAA activities included "Holding two statewide agricultural workshops, one in Albuquerque and one in Santa Fe, with a total of 78 attendees "Holding or attending 27 regional workshops, demonstration workshops, and acequia outreach meetings, with a total of 559 attendees, in the counties of Rio Arriba, Guadalupe, Mora, San Miguel, Colfax, Santa Fe, Sandoval, Bernalillo, and Taos "Providing technical assistance to 227 individuals throughout the state "Assisting in the preparation of 5 acequia restoration plans, with a total of 70 participants, in the counties of Taos, Sandoval, Guadalupe, and Rio Arriba Community Organizing and Leadership Development Program This program carries out activities that are essential to NMAA's mission including the coordination of the Congreso de las Acequias, which is the voting membership and governing body of the NMAA This includes the annual cycle of engaging leaders in the process that directs policy recommendations of the NMAA Additionally, this program area encompasses policy advocacy including leadership training on the legislative process A new initiative under this program was the Escuelita de las Acequias Congreso de las Acequias The annual Congreso de las Acequias meeting is held every November for delegates to vote on resolutions and elect the Concilio In November 2011 the meeting had 250 attendees and included workshops on acequia governance, USDA programs, and community organizing The governing body of the NMAA also adopted several policy resolutions that formed the policy platform for use in policy advocacy at the state and federal levels In order to diversify leadership within the Congreso de las Acequias, the NMAA convened special meetings of a Youth Caucus and Women's Caucus with approximately 10 participants The participants elected one person from each caucus to be a delegate in the Congreso Additionally, the NMAA engaged in the following activities relating to the Community Organizing and Leadership Development Program "Newsletters Four quarterly newsletters were published (spring, summer, fall, and winter) Each quarterly issue was distributed to approximately 5,000 contacts Online newsletters were emailed on a monthly basis, and occasionally additional email blasts were sent for specific events or alerts as well Each online newsletter was sent to approximately 3,200 contacts "Legislative Training The NMAA hosted a training for approximately 20 people on the legislative process and policy advocacy, including a tour of the state capitol "This program includes a new leadership development initiative of the NMAA entitled the Escuelita de las Acequias Through this project, NMAA seeks to support community leaders through a popular education process that affirms their role as community leaders and contributes to a larger acequia movement by connecting leaders from various regions of the state The Escuelita builds upon existing knowledge, peer learning, and service learning and also provides opportunities to enhance skills in the areas of public speaking, project management, and community organizing In 2011, NMAA held its first convening, or encuentro, of the Escuelita de las Acequias and engaged over 50 adult and youth leaders in leadership development activities
