 The downtown area encompasses 40 city blocks and includes the Derrick Floor oilfield monument and the Oil Field Plaza with its grounds and fountain, as well as the 4 other bronze monuments in the 'History in Bronze' project including their landscaping. The streetscape of the downtown area includes approximately 250 trees and numerous other plants. The Heritage Walkway with its 7 fountains depicting the culture of Artesia made up of handmade ceramic tiles and colored concrete with many shade trees is also part of Artesia's downtown. This expense amount covers the maintenance and repair, security, electricity and water for the entire area.

4b (Code:) (Expenses \$ 72,992 including grants of \$ 0) (Revenue \$ 1,800)
 The Baish Veteran's Park will be on the grounds of the new City Hall Campus. The park has been designed to have a wall with plaques recognizing all local area service men and women, past and present. Extensive grounds renovation will be made to create an attractive, inviting park to honor all veteran's of North Eddy County.

4c (Code:) (Expenses \$ 22,826 including grants of \$ 0) (Revenue \$ 375)
 Downtown Artesia is brilliant during the Christmas season with lights placed throughout the downtown area, and huge illuminated light pole decorations placed the length on Main Street. On the first Tuesday in December "Light Up Artesia" is held. All stores on Main Street remain open into the evening. Vendors are set up on the sidewalks selling food. The revenue comes from the the vendor's booth fees. A large percentage of Artesia residents participate in this annual night-out for Christmas shopping
