 Each year Phoenix Pride hosts the "What's Your Story?" Community Essay Contest and this past fall we added a new element called the "Creative Expressions" Contest to include any form of creative expression from written word, poetry, dance, song, art, video, etc., anything to creatively express an individual's Coming OUT process or story. We encourage the entire community to submit their personal coming out expressions, and selected winners are invited to share their stories at our annual OUTdayPHX event. OUTdayPHX is a program created to recognize, promote and celebrate "National Coming OUT Day," an internationally-observed civil awareness day for coming out and discussion about gay, lesbian, bisexual, and transgender (LGBT) issues. It is observed on October 11 every year by members of the LGBTQ communities and their supporters. Each year we invite the community to an all-ages, family-oriented event in a public venue where they can hear, learn about, and recognize the lives of brave and authentic local LGBTQ individuals who have been OUT for many years or are just beginning to come.

 The OUT Phoenix E-News: The purpose of this program is to provide to the LGBTQ community with a virtual calendar resource and e-news letter about LGBTQ focused non-profit organizations in the metropolitan Phoenix area and the activities and fundraising events available to the community and our allies. This program was created to assist in increasing public awareness about the LGBTQ community and LGBTQ focused non-profit organizations in the metro Phoenix area.

 Phoenix Pride Community Grants Program: Four organizations were selected to receive "organization capacity grants" from the Pride Community Grant Fund, administered by Arizona Community Foundation in December 2011. Organization Capacity Grants are intended to support efforts to strengthen the operations of nonprofit organizations serving LGBTQ community in Maricopa County. Grant applications can address areas such as, new program/service development and implementation, enhancement of existing programs/services and/or stabilizing and sustaining current programs or services. Grants were awarded to the following organizations: 1n10 will receive a grant of \$12,500 to support the expansion of their LGBTQ youth drop-in center in central Phoenix; Chrysalis is being awarded \$12,500 to provide training and resources across all of their programs regarding domestic abuse that relates to the LGBTQ community; Hospice of the Valley will receive a grant of \$5,000 to improve bereavement services for LGBTQ individuals and their families; and the Greater Phoenix Gay and Lesbian Chamber of Commerce (GPGLCC) is being awarded \$5,000 to continue their
