MEDICAL SERVICES ARE PROVIDED IN THE AREAS OF AUDIOLOGY, VISION, NUTRITION, SPEECH, ORTHOPEDIC, MEDICATION, PHYSICAL THERAPY, ORTHOTICS, PEDIATRICS, OCCUPATIONAL THERAPY, REIKI THERAPY, DERMATOLOGY AND CARDIOLOGY. THE CLINIC ALSO PROVIDED NEEDED SURGERIES AND TESTING WITH SHRINER'S INTERNATIONAL AND UNIVERSITY OF ARIZONA MEDICAL CENTER. THE CLINIC ALSO HAD IT'S 6TH ANNUAL CLEFT PALATE AND CLEFT LIP MISSION WHICH PROVIDED TREATMENT AND SURGERY FOR 41 CHILDREN.
