Conservation Policy: Sky Island Alliance continued its leadership role bringing climate change to the forefront of regional natural resource management by convening Between a Rock and a Hot Place, the second workshop in our climate change adaptation series, and establishing the Arizona Climate Change Network. This network of informed and engaged land managers, researchers and conservationists is developing actionable strategies to build resilience in Madrean forests, grassland, desert and riparian ecosystems.
 Sky Island Alliance continued to fight large-scale mining activities that pose one of the gravest threats to the health of the Sky Island landscapes and its inhabitants, and in 2011 we saw a barrage of harmful mining proposals targeting two Sky Islands. Sky Island Alliance's letter writing workshops were key in educating community members about these harmful proposals and providing information and mechanisms for them to voice their opposition. We also responded to three separate mineral exploration proposals for the Patagonia Mountains, all of which threaten the watersheds, riparian areas, critical wildlife corridors, and big cat borderlands habitat found in this small Sky Island gem.

4b (Code:) (Expenses \$ 137,378 including grants of \$) (Revenue \$)
Landscape Restoration: 2011 was a watershed year for restoration with rain filling the newly restored Cloverdale Cienega and riparian surveys and eradication of invasive species conducted across the region. Across the board we advocated for coordinated and robust management of the landscape while working tirelessly to lower road densities, repair upland erosion, restore riparian areas and aquatic ecosystems, reintroduce rare species and eradicate harmful invasive species, and celebrate the revival of our magnificent Sky Island landscape. WE conducted surveys to assess and collect baseline data on the health of the Greater Huachuca Grasslands complex and Las Nutrias Headwaters watershed as it flows into Sonora. In concert with our partners and engaged landowners on both sides of the international border, we began development of a comprehensive restoration plan - a coordinated eradication of invasive species and restoration of riparian areas - to be implemented in 2012 - 2013.

4c (Code:) (Expenses \$ 160,446 including grants of \$) (Revenue \$)
Northern Mexico Conservation Program: Thanks to one volunteer who catalogued all of Sky Island Alliance's ocelot photos taken since 2007, SIA was able to identify individual ocelots photographed and confirm the location of the northernmost breeding population of ocelots on the continent - the Sierra Azul Mountains of Sonora. Our remote cameras also corroborated the presence of a second jaguar thirty miles south of the border in the Sonoran Sky Islands. In March of 2011 Rancho El Aribabi was designated as a Private Natural Preserve, protecting 10,000 acres of woodland forests, Sonoran Desert and riparian habitats, a wide array of protected species of plants and animals, including jaguar and the northern most breeding population of Sonoran ocelots. To better understand public perception of borderlands conservation, Sky Island Alliance conducted a nationwide survey focusing on border security and land management in the region. These results will guide our advocacy in reducing current and future threats by educating the public about the unique biodiversity of the Sky Island borderlands, the threats posed by border security infrastructure and activities and the need to maintain connectivity across the international boundary.
