Two of The Peaks residents and The Lodge executive director are docents of the museum, providing education on local history, and discovers of the Colorado Plateau to area schools, associations, the public and Peaks residents. The Peaks also provides assisted living, progressive memory care, rehabilitation, long-term care, and skilled nursing. The Peaks offers the opportunity for residents to "age in place," which encourages the resident to remain in their apartment homes receiving assistance with activities of daily living through personalized levels of care. Northern Arizona Senior Living Community, LLC is a comprehensive senior living and healthcare campus consisting of 58 skilled nursing beds, 96 assisted living units, and 39 bungalows.

For the fiscal year ended December 31, 2011, The Peaks participated in various charitable initiatives such as the provision of discounted care through participation in the Arizona state Medicaid program. We average 18 Medicaid patients in our skilled nursing facility on a daily basis and discounted their care by \$271,611 during the 2011 year. In our lodge we averaged 23 residents on a daily basis and discounted their care by \$25,003 during 2011. We have a partnership with the Museum of Northern Arizona (MNA) that consists of supporting an art collection within The Peaks and three museum docent programs. We believe this art enriches the lives of our residents and the community as a whole. Each month we support the museum with an \$825 monthly fee (Value \$9,900). In the budget for 2012 we added an additional \$5,000 to support the programming held at The Peaks by MNA. We currently have a \$7,500 endowment at Northern Arizona University within the Behavioral and Social Science Department for scholarships to students who plan careers that would support seniors. The endowment minimum was recently raised to \$25,000. The Peaks participated in the American Cancer Society "Climb The Mountain" event. We sponsored several of our employees to climb the 7 mile hike up the mountain north of the Peaks. We supported Flagstaff Big Brothers and Big Sisters by sponsoring two bowling teams during their fundraiser in 2011. We also supported Northland Hospice, which is a local non-profit hospice agency, by sponsoring a hole at their annual golf tournament and fund-raiser (Value \$2,400). During the 2011 holiday season The Peaks sponsored a food drive benefitting the Northern Arizona Food Bank.
