During calendar year 2011, our Business Expansion and Retention Project visited 888 companies in our area, and provided help and referrals to assistance 437 times. This effort provided direct cash benefits to the businesses of \$360,650 with an increase of company revenues reported by the business of \$883,000. The companies leveraged \$1,855,000 in private investment in new plant and equipment with an additional \$13,300 of local revolving loan funds. Report cost savings to the companies is reported by them to be \$2,650 and \$883,000 increase in revenues. The companies reported 32 jobs created and 5 jobs retained.

This year we helped move the program to 16 other counties in Utah. We were fiscal agent for this program in other areas as well.

This arrangement increased our revenues and expenses. 2012 will show other areas taking over their own expenses. Funds for our area have increased and will be expended over 2012-13.

The Children's Justice Center expanded into a new facility. The program provides a safe environment and temporary housing for abused women and children. It also provides other essential resources such as counseling, clothing, food, etc.

There was \$10,995 raised for furnishings and equipment all of which directly benefited the Center with no overhead or expenses.

Utah State University - Eastern raises scholarship funds from our outreach efforts and payroll deductions. All raised funds go directly to the scholarship fund with no overhead or expense. Funds that had been gathered in '11 were paid out after Jan 1 2012.
