Grants to Benefit Needy in General - Haiti - Clean Water Reiser Relief, Inc cooperated with Healing Haiti in a program designed to provide clean water to the poor in Haiti Under this cooperative program, Reiser Relief, Inc provided grants to Healing Haiti, which Healing Haiti used to operate a water truck that delivers 364,000 gallons of clean chlorinated drinking water every month to the poor in the slum of Cite Soleil, Haiti This program delivers loads of water 6 days per week, 52 weeks per year, to thousands of families Funds support local Haiti driver salaries, fuel and maintenance The number one cause of malnutrition being a lack of clean water, this program brings life saving water daily to those in need Healing Haiti, was formerly known as BUYA ORG, and is a publically supported 501c3 organization, located in White Bear Lake, MN, that provides help to the poor, the vulnerable, and the disadvanted in Haiti

Grants to Benefit Needy in General - Haiti - Schools Reiser Relief, Inc cooperated with Healing Haiti in a program designed to provide schools for the poor children in Haiti Under this cooperative program, Reiser Relief, Inc provided grants to Healing Haiti, which Healing Haiti used to support two schools in Haiti Reiser Heights in Lespinasse/Dante with over 300 children, and Terra Promise in Cite Soleil with over 425 children We help by providing funds to pay teachers salaries so that school fees can be low enough to allow even the poorest families to send their children to school We have also constructed classrooms, built school benches and given assistance for school uniforms, school and medical supplies, food and clean water

Grants to Benefit Needy in General - Haiti - Grace Village Reiser Relief, Inc cooperated with Healing Haiti in a program designed to provide assistance to the poor in Titanyen, Haiti Under this cooperative program, Reiser Relief, Inc provided grants to Healing Haiti, which Healing Haiti is using to operate a cooperative program known as Grace Village Grace Village includes 16 acres of land in Titanyen, Haiti Grace Village includes Maranatha House Orphanage, which is a Christian orphanage currently housing 30 to 40 orphaned children The program is erecting a new building a new home for the children who have lost their families to extreme poverty, hurricanes and AIDS Grace Village also feeds about 75 children daily, as well as the elderly poor The elderly in Haiti have a life expectancy of only about 50 years, and rarely have adequate resources to provide for their own meals or clothing Grace Village is providing emergency relief to the poor and elderly in Haiti On January 12, 2010, Haiti was hit by a devastating earthquake, which greatly increased the needs there
