Train high school students in information technology, engineering drafting, or accounting, as well as the professional skills needed to enter and succeed in corporate America. Seventy percent of all students admitted into training finished.

Hire students and place them at various corporations to work in a real capacity doing activities that companies value. In the process, students obtain ongoing mentorship from corporate professionals and learn that succeeding in the corporate world is within their reach. Major corporations in Houston, the Twin Cities, and Chicago, most of them Fortune 1000 companies, engage Genesys Works students. After leaving Genesys Works, students get jobs paying livable wages.

Actively guide students through the college admission process as well as college applications. By the end of the year, students have realized that they can succeed in a corporation, but they need a college education to live well. At conclusion of the 14-month program, over 95% of those who complete the program go on to post-secondary as compared to only half of the graduates from inner-city schools. An independent cohort study found that 86% of our interns persist beyond their first year of college.
