There are six phases in the core Scouting program. Tiger Cubs for first grade boys, Cub Scouts for second and third grade boys, Webelos Scouts for fourth and fifth grade boys, Boy Scouts for boys age 11 through 17, Varsity Scouts for 13-15 year old boys, and Venturing for boys and girls age 14-20. All six phases strive to accomplish similar important purposes (servant leadership, character development, participating citizenship, and personal fitness) in a manner that has proven to best meet the developmental needs of the age of the youth involved - and gives youth and adults skills that will prepare them for adulthood. Approximately 5,000 youth and 2,500 adults enjoyed quality Scouting programs in over 300 community units. The Council was recognized by the Boy Scouts of America as a 2011 Silver Journey to Excellence Council. The Council was again among the top 10% of all councils in the BSA in quality units, Boy Scout market share, youth member retention, renewed unit charters, trained adult leaders, Cub Scout and Boy Scout outdoor programs, and youth member advancement. Over 140 young men became Eagle Scouts. The Council has the best youth retention (over 79%) record in Washington or Oregon, and the 9th best among the BSA's nearly 300 councils. We rechartered over 90% of our Scouting units for the eighth consecutive year. Over 30,000 service hours were performed for the community as part of Good Turn for America. The Council collected over 50,000 pounds of food in 2011 for area food banks.

4b (Code) (Expenses \$ 2,300 including grants of \$) (Revenue \$ 2,036)

Designed to meet the critical needs of youth in schools, Learning for Life has two phases – a classroom based curriculum supplement and Exploring, a school-to-work program that helps teenagers learn more about a career or special interest. Learning for Life is for males and females and works to accomplish similar purposes, but differs in its delivery. About 230 youths were involved in this program.
