NOTE 1 -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES :

Entity:

Community Services of Moses Lake, Inc. (the Organization) is a nonprofit organization incorporated under the laws of the state of Washington. The Organization has been granted tax-exempt status under Section 501(c)(3) of the Internal Revenue Code. The Organization was formed to alleviate hunger in Central Washington by providing nutritional assistance and exemplifying the spirit of providing for one's neighbor. The Organization participates in federal programs administered by the Washington Department of Agriculture which provide funding and food commodities. The Organization serves communities in Grant, Lincoln, and Adams counties.

Basis of Accounting:

The accompanying financial statements are prepared on the accrual basis of accounting. Under the accrual basis of accounting, revenues are recognized when earned, and expenses are recognized when incurred. Receivables are recorded for grants if the Organization has met the grant requirements necessary to earn the income. For purposes of the statement of cash flows, the Organization considers all highly liquid debt instruments with a maturity of three months or less to be cash equivalents.

Basis of Presentation:

The Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets. The Organization did not have any restricted net assets as of December 31, 2011.

Contributions:

Contributions received are recorded as unrestricted, temporarily restricted or permanently restricted support, depending on the existence or nature of any donor restrictions.

Donated Services and materials :

The Organization recognizes donated services that create or enhance non-financial assets or that require specialized skills and would typically need to be purchased if not provided by donation. No donated services meet this criteria for recognition. Donated materials are recorded as support at estimated value and expensed or capitalized as appropriate.

Equipment:

Equipment is stated at cost. Depreciation is computed on the straight-line method over the estimated useful life of the asset. Assets costing \$1,000 or more are capitalized. State and federal governments retain a residual ownership interest in equipment purchased using grant funds. If the Organization should cease operations, the equipment purchased using state and federal grant funds would be forfeited to the government.

Food Inventory:

The Organization does not maintain an inventory of food. Because of the perishable nature of food inventory, the Organization distributes food immediately. Food distributed by the Organization consists of donated food, USDA commodities and purchased items. Donated food is stated at \$1.50 per pound. USDA commodities are stated at the estimated value provided by the U.S. Department of Agriculture. Purchased food is stated at cost.

NOTE 1 -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued):

Use of Estimates:

Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and reported revenues and expenses. Actual results could differ from those estimates.

NOTE 2 -- ECONOMIC DEPENDENCY:

The Organization depends on grant revenues. The Organization estimates that \$184,000 of its expected \$278,000 in revenues (excluding food commodities) for the contract year ending June 30, 2012 will be received from the Washington State Department of Agriculture.

NOTE 3 -- CONTINGENCIES:

Amounts received or receivable from grantor agencies are subject to audit and adjustment by grantor agencies. The amount of expenses which may be disallowed by the grantor, if any, cannot be determined at this time. The Organization expects such amounts to be immaterial.

NOTE 4 -- GRANTS RECEIVABLE:

Concentration of credit risk:

The Organization receives grants from a limited number of sources. Of the \$40,910 in grants receivable at December 31, 2011, \$31,460 are from three programs administered by the Washington State Department of Agriculture.

Allowance for doubtful grants:

Management believes all grants receivable will be collected. No allowance for doubtful grants is deemed necessary.

Aging:

No grants receivable are older than 90 days.

NOTE 5 -- INCOME TAX STATUS:

The Organization has been classified as an other-than private foundation and is tax-exempt under Section 501(c)(3) of the Internal Revenue Code. The Organization is subject to a tax on income from any unrelated business.

NOTE 5 -- INCOME TAX STATUS (continued):

Income tax benefits are recognized for income tax positions taken or expected to be taken in a tax return, only when it is determined that the income tax position will more-likely-than-not be sustained upon examination by taxing authorities. The Organization has analyzed tax positions taken for filing with the Internal Revenue Service and all state jurisdictions where it operates. The Organization believes that income tax filing positions will be sustained upon examination and does not anticipate any adjustments that would result in a material adverse affect on the Organization's financial condition, results of operations or cash flows. Accordingly, the Organization has not recorded any reserves, or related accruals for interest and penalties for uncertain income tax positions at December 31, 2011.

The Organization is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Organization believes it is no longer subject to income tax examinations for years prior to 2008.

The Organization's policy is to classify income tax related interest and penalties in interest expense and other expenses, respectively.

NOTE 6 -- SUBSEQUENT EVENTS:

The Organization has evaluated subsequent events through the date of this report, which is the date the report was available to be issued. The Organization has disclosed all subsequent events that would materially effect the financial statements at December 31, 2011.
