Medical Services: Mt Baker Planned Parenthood provides comprehensive reproductive health care for women and men. Services include birth control method counseling services and supplies; pregnancy testing and option counseling, first-trimester abortion care, education, and support; referrals for prenatal care, parenting, adoption; annual checkups, pap smear, breast and pelvic exams; testing and treatment of sexually transmitted diseases; colposcopy and LEEP services; vasectomy and post-vasectomy exams and testing; and health education.

Mt Baker Planned Parenthood provided 19,656 preventive and essential medical services to 11,320 women and men in 2011. MBPP health centers' nurses provided 11,530 pregnancy tests and distributed 11,571 units of

Community Education:

Mt. Baker Planned Parenthood offers education programs free to public schools and other social service agencies. Our Health Educators are dedicated to providing quality programs and frequently work closely with teachers and program coordinators to design presentations that are customized to a specific classroom or group.

In 2011, MBPP educators offered 285 educational programs that reached 4,275 people.

The Public Affairs Department provides information, support, training that helps MBPP supporters influence public policy and the legislature process.
