Cascade Vocational Services mission (CVS) is to empower individual with disabilities to enhance their quality of life. We accomplish this through community partnership and service excellence. We seek to find creative employment solutions in our community and identify the unique skills and abilities of those we serve. Businesses have been willing to look at alternatives to their traditional hiring practices and instead look at their needs and CVS staffs have fostered unique partnerships creating many employment opportunities that benefit all parties. In 2011 CVS served a total of 149 people and created a total of 69 new job opportunities for individuals with disabilities throughout Whatcom County. In addition to this CVS participants also provided a total of 859 hours of volunteer work in a variety of not for profit organizations in order to gain more marketable employment skills. CVS has worked with many local employers over the past year to create these opportunities. One of the most outstanding accomplishments achieved in 2011 is the partnership created through the CVS Business Advisory Council. The vision of the council is: "We are business members of Whatcom County committed to supporting the development of opportunities for people with disabilities through recruitment, hiring, training and improved customer service within our community." The insight and dedication of these local business members has been extremely valuable for CVS staff, our participants and the community at large.

Cascade Christian Home (CCH) provides 24 hour care in a boarding home setting for up to 8 individuals with developmental disabilities and/or severe medical needs. CCH has been specializing in dementia care.

Cascade Supported Living (CSL) provides residential services to adults with disabilities in an apartment setting. CSL provides services to 11 individuals who each live in their own apartments. CSL also has cluster housing where 24 hour over-site is provided to clients in need of extra support.

Whenever any business is conducted with an outside firm the Board and staff are asked if they have any relationships that could be construed as being a conflict of interest. If they do they are required to not be involved with the bidding process or involved with the process that determines who will get the job.

990 Part VI, line 15 : The process for determining compensation for the management staff excluding the Executive Director is set according to an agency pay scale. This pay scale is determined by looking at the description of the position and finding out what other like agencies are paying for those job positions and responsibilities. Other factors are figured into this determination such as what the agency is getting paid in contract to provide those services and looking at fringe benefits and whether other agencies are offering comparable benefits or not. The Executive Director and agency Bookkeeper make a pay scale recommendation to the Finance Committee of the Board of Directors. The Finance Committee then studies the information and recommends to the full Board of Directors where the final approval comes from. The Executive Directors pay is determined by a like position and job description comparison performed by the Board of Directors. Any changes to the Executive Directors pay and/or benefits is discussed and voted on by the full Board. It is agency procedure that no change may be made without written approval from the Board of Directors.
