The Seattle Public Library Foundation helps the Library build its collection and resources, offer programs for patrons of all ages, and better serve the needs of our community. We do this by securing and managing donations from individuals, businesses and foundations to support the Library above and beyond what public funding provides.

4 Describe the organization's program service accomplishments for each of its three largest program services, as measured by expenses. Section 501(c)(3) and 501(c)(4) organizations and section 4947(a)(1) trusts are required to report the amount of grants and allocations to others, the total expenses, and revenue, if any, for each program service reported.

The Foundation provided grants to The Seattle Public Library to support primarily three areas: collections, free public programs, and capital improvements. In 2011, the Foundation gave grants totaling almost \$1.5 million to support the enhancement of the Library's collection. Those dollars allowed the Library to buy books, audiobooks, DVDs and music recordings for adults, teens and children, making more than 42,000 new items available on library shelves across the city. Approximately 25% of the 50,000 new ebooks and e-audiobooks added to the Library's online collection were funded by the Foundation. Currently nearly one in five items in the Library's collection was purchased with Foundation funding.

Last year, the Foundation supplied \$1.1 million to support free public programs at the Central Library and in the branches. These programs include early literacy activities for pre-school children, the Library's annual Summer Reading Program, homework help for students, book groups for seniors, and public presentations by leading authors, scholars and artists. Last year, more than 207,000 people attended 6,400 free public programs offered at the Library. In 2011 the Foundation contributed \$558,000 to the Library for deep cleaning, furniture repair and replacement, and other building improvements throughout the system.
