Conservation of the endangered Snow Leopard and its mountain ecosystem In 2011, the Snow Leopard Trust worked with over 1,400 herding families across 50 villages in India, Mongolia and Pakistan through community-based conservation programs that protect the snow leopard and improve the livelihoods of herders All participants agreed not to harm snow leopards in exchange for support for income-generating programs In Mongolia, 369 herding families made 19,900 handicrafts and earned a total of \$26,000 Handicrafts are sold by the Trust through international outlets In Mongolia and India, herders insured a total of 4,600 livestock against snow leopard depredation In Pakistan, 9,700 livestock where inoculated against life-threatening diseases and 86 families earned an average of \$66 from marketing of excess livestock due to healthier herds

Education of the public about Snow Leopards and their environment In India, the Snow Leopard Trust worked with 80 teachers and 1,200 children in regions of Himachal Pradesh and Jammu & Kashmir where snow leopards are present 143 children attended nature camps, and 750 learned about high altitude food chains in an event called The Living Himalaya In South Gobi, Mongolia, the Trust ran drawing and poem competitions for school children who made 110 paintings of snow leopards and wildlife and 80 poems of nature and wildlife topics In addition, the Trust conducted educational workshops with multiple herder communities in India and Mongolia to raise awareness and build positive values towards snow leopards and other wildlife

Research and monitoring of Snow Leopards and their environment In 2011, as part of our long-term research in South Gobi, Mongolia, we GPS collared three new snow leopards, one male and two females, and tracked their movements, as well as the movements of previously collared snow leopards to ascertain habitat usage patterns and home range sizes These activities provided valuable information for the formation and management of an official Protected Area, We also conducted snow leopard population studies using research cameras in key habitats of China, India, Kyrgyzstan, Mongolia and Pakistan For example, 18 snow leopards were found in our study area in the Central Tien Shan Mountains of Kyrgyzstan
