Advocacy - ADWAS has advocates on staff to assist people who are victims of domestic violence and/or sexual assault and need help. Services are free of charge and available to people who are Deaf, Deaf-Blind or Hard of Hearing and residents of King, Pierce or Snohomish County. During 2011, ADWAS served 108 women and 41 children through our Transitional Housing Program, 3,301 as part of our outreach and education program, 1,511 callers to our National DV Hotline Counseling - The counseling program offers victims of domestic violence and sexual assault the following services: Short-term crisis counseling; On-going individual/family therapy related to domestic violence & sexual assault; Group counseling related to childhood sexual assault and domestic violence; Psychosocial assessments and evaluation of sexual abuse of children; Client advocacy and referrals.

Positive Parenting - The Positive Deaf Parenting program offers parenting education and support to all members of the Deaf community. ADWAS offers a variety of classes and workshops throughout the year in King County.
