Nutritious meals are available for qualified clients through collaboration with Chicken Soup Brigade.

The Oasis Youth Program served more than 350 gay, lesbian, bisexual and transgendered youth, ages 14-24 at its drop in center. Oasis provided a variety of health and safety services.
