home delivery for approximately 60 clients who are physically unable to travel to the
Food Bank on a weekly basis.

Emergency Service: Operates three days per week with three and one half hour shifts.
Provides assistance to prevent evictions and utility shutoffs. Also provided

approximately 4,500 client visits during the year.
