Since 2008 SPF and the Farmland Legacy Program have partnered four times by leveraging public and private dollars to protect over 285 acres of Skagit Valley agricultural land along the I-5 corridor. Since 1996, the Farmland Legacy program has protected more than 9,000 acres of Skagit farmland.

* Defeated HB 1222. Worked in collaboration with FutureWise to successful defeat HB 1222, a bill that would have allowed the expansion of the City of Mount Vernon onto farmland.

* Defeated Proposed Senate Bill S-0902. Collaborated with Association of Cities, City of Mount Vernon, City of Burlington, WSU and others to successfully stop a bill that proposed to eliminate the use of State capital funds for new or existing projects within the 100-year flood plain. This bill would have had severe and devastating consequences to WSU's Northwestern Research & Extension Center, a critical facility and institution to the agricultural industry in Skagit Valley and all of Puget Sound agriculture.

* Farms, Fish and Flood Initiative. Signed a "Good Faith Agreement" to continue partnering with The Nature Conservancy, Western Washington Agricultural Association, Washington State Department of Fish & Wildlife to create and advance mutually
