Delivering bibles and Christian literatures to the persecuted church in the Gospel restricted nations such as North Korea, China, some Islamic nations, and Israel with the combined effort of other partnering ministries, mission organizations, and missionaries. We also have broadcasted one hour a day over short wave to reach believers and Christian leaders in North Korea. This year we distributed 104,815 copies of North Korean bibles and 42,930 Chinese bibles.

4b (Code _____) (Expenses \$ 144,399 including grants of \$ 82,453) (Revenue \$ _____)

Raise up leaders in the restricted nations for them to minister and to propagating the Gospel of Jesus Christ by having bible school, seminaries, and conferences along with other ministries, missionaries, and organizations. Equip potential leaders among Korean living in Korea and living around the world to enter into the restricted mission fields. Distribute newsletters and prayer letters to inform the needs of supporting leaders and current situation of the persecuted church in the restricted nations. 96 ministers and professors taught a total of 6,192 hours to 454 students in 8 different courses.

Facilitating and supporting other ministries and missionaries for networking and partnering in delivering and teaching the Word of God and train people to be missionaries in the restricted nations. We held two conferences in this year and over 524 participants attended. We also held mission bible study school and total of 185 students were trained. In addition, we managed trips to China for 119 people in 12 teams.
