Our vision is that all children have what they need to thrive through the abundance of support from our community We meet the vital, growing and changing needs of our community’s most vulnerable children by collecting and purchasing essential items for infants and children, ages birth to 12 , and distributing them, free of charge, via a network of local family-assistance service providers

The success of our program is in being able to provide essential items to children from low income and homeless families, birth to age 12 living in our geographic catchment area These life basics enable struggling and stressed parents to better care for their kids EBC gives parents things that promote safety and health, provide comfort, learning and a sense of worth to their children Access to Eastside Baby Corner support is available only through qualified partner agencies who are providing services to the families in need Case managers from these organizations assess the needs of the children, request the items through our online ordering system, and pick up and deliver directly to the families Currently, there are collaborative agreements with more than 120 providers, working within 47 agencies who are eligible to order 20 to 40 items each week, 50 weeks a year (An item could be an entire bag of clothing, a package of diapers or a new car seat) The providers are from a spectrum of public and private agencies, schools, and hospitals that work with children from all backgrounds, races and ethnicities It is a central tenet of our mission to give away all donated and purchased items free of charge EBC attempts to fill the agency requests by matching age, gender, and personal preferences from a warehouse of donated and purchased items As an eco-sensitive organization, we recycle community donations of clothing, cribs, strollers, high chairs, beds, bicycles, bedding and more, we wisely purchase high-demand and high-need items, such as diapers, port-a-cribs, car seats and baby formula Donations are checked for safety and recalls, and operation manuals are reprinted as needed to accompany distributed goods In 2011, EBC filled an average of 700 orders each week For the year, those orders included 1147 car seats, 199,250 diaper changes for individual children, 733 layettes for newborns, and over 400 port-a-cribs Ten area food banks received enough diapers for 200,000 diaper changes The need for nourishment for kids continues to grow in our community in 2011, EBC gave out 6,036 cans of formula and provided 9,649 baby food meals to individual children and through local food banks EBC distributed more than 6,400 bags of clothing to infants, children and expectant mothers last year Eastside Baby Corner leverages cash contributions with in-kind donations of facility use and services For 2011, the total values of these in-kind donations were Warehouse rental cost \$ 76,380 Accounting and Bookkeeping Services \$ 26,798 Director and Management Services \$ 60,504 Information Technology Services \$ 30,000 Total in-kind rent & services not ----- Included in gross income/expenses \$ 193,682 Donated goods, including clothes, toys, Books, furniture, bedding and equipment \$ 3,691,601 Total in-kind \$ 3,885,283The method used to calculate the value of in-kind donations and distributions (which are included in the figures in Part 1, lines 8 and 13) was changed from retail replacement value in 2008 to thrift store value in 2009 to better conform with industry standards EBC operates with a near all-volunteer force - approximately 45 core volunteers plus an additional 100 volunteers each week By the end of 2011, EBC employed two full-time and three part-time staff members Working together, an estimated 500 at-risk children in greater east King County are served each week In 2010, Eastside Baby Corner completed its initial three-year strategic plan and the first transition phase from an all-volunteer organization to one with a more sustainable funding and governing structure A new strategic plan, refreshed vision and mission, and articulated organizational values are in the final stages of review, with an anticipated release date of August, 2012
