




The Organization donated approximately 1,506,000 pounds of seafood in 2011 and directly coordinated the processing and distribution of this product to various hunger relief organizations. It also supported approximately 174,000 pounds of additional seafood distributions through its regional food bank partners. Total efforts provided approximately 1,680,000 pounds of seafood portions to hungry Americans in 2011, or approximately 8.4 million seafood meals.
