Powerful Choices Middle School Groups - Provide girls in the 8th grade with education and pro-social activities to promote positive identity, healthy relationships and empowerment skills The curriculum involves weekly groups, monthly mentoring sessions and a family engagement component During the first 5 months of the year, Powerful Voices served 30 young women in the 8th grade at Asa Mercer and Aki Kurose Middle Schools From June to December 2011, Powerful Voices served 54 young women through Girls Rising summer program and groups at three middle schools adding Denny International to Asa Mercer and Aki Kurose Community Engagements - In 2011, Powerful Voices hosted the 2nd Annual Girlvolution Conference, a girl-led event reaching over 150 youth and adult allies Additionally, we trained 55 social justice advocates through Girl Justice workshops offered in the community Employment Program - In 2011, 22 girls gained pre-employment and career building skills through participation in Powerful Voices employment programs 11 young women participated in Develop Your Voice and Speak (DYVAS), creating a zine to educate the community about social justice issues 11 other young women participated in ActiveVistas, developing and presenting pworkshops at the Girlvolution Conference Case Management - Powerful Voices helped 22 girls meet their goals of service-learning, employment and education through case management services Young women ages 12-17 years old were referred to this program through Seattle Youth Violence Prevention Initiative In-detention Programming - In 2011, Powerful Voices staff facilitated educational and pro-social workshops with 50 young women who were detained at the king County Youth Detention Facility
