Mobius was founded in January 2005 with the merger of the Inland NW Science & Technology Center & The Children's Museum of Spokane. These two organizations joined with a common mission to be the region's center for hands-on science, arts, and cultural education for the "kids" in every stage of life. This mission is being accomplished through two efforts: Mobius Kids (which opened September 2005) and Mobius Science Center (with completion projected by 2012). Mobius Kids is supported by businesses, schools and residents throughout our community. In the last year more than 65,000 children and families have benefitted from the hands-on arts, science, and cultural education that Mobius Kids provides.
