**Programs & Services:** Grantmakers of Oregon and SW Washington provides services to members and the public. The organization has an e-newsletter that captures news about philanthropy and the community. The newsletter reaches 550 individuals affiliated with grantmaking organizations. The website is a resource for members and for persons wanting general information on philanthropy or grantmaking. The organization houses a library of resources that are available to members and staff responds to requests for research. In 2011 the organization offered 23 programs attended by 750 members who are trustees or staff of grantmaking organizations. The programs included training and education on the craft of grantmaking, networking events for funders and programs that focused on community issues such as education, health, environment, arts, social services, and community building.
