



During 2011 Friends of Cloud Mountain conducted 32 retreats ranging in length from 2 days to 27 days. Most of these retreats were organized solely by Cloud Mountain. Some of the retreats were presented in cooperation with other 501(c)3 organizations, such as Brahma Vihara Foundation, Kagyu Changchub Chuling, and Center for Sacred Sciences. Retreats focused on various aspects of Buddhist teachings or practice, and usually feature a teacher or teachers well known among practicing Buddhists. Lectures, meditation, or related activities are scheduled throughout the day. Participants have little free time and are often expected to continue meditation on their own during unscheduled times. Retreats are staffed by Friends of Cloud Mountain employees, with significant amounts of labor provided by the participants themselves, which helps to keep retreat fees low. The fee for each retreat depends on the length of the retreat and related costs. Generally every retreat accepts some work-exchange participants who pay a reduced fee. There is a need-based scholarship fund (funded largely by donations from the community) available to assist low-income individuals to attend retreats.

### Part VI

David Branscomb served in 2011 as both Board President and Executive Officer, and was compensated as an employee for his work as Executive Director. Laura Haurer served as Board Treasurer and Finance Manager and was compensated as an employee for that work.

David and Laura are not in a family relationship, as previously reported.

David Branscomb is also legal owner of Cloud Mountain Retreat Center's buildings and the retreat center land, and is paid a monthly rental by Friends of Cloud Mountain in the amount of \$4,500 per month. When matters that concern conflict of interest arise regarding compensation or the lease agreement, David abstains from voting on these matters. All Board members fill out an Annual Conflict of Interest Statement.
