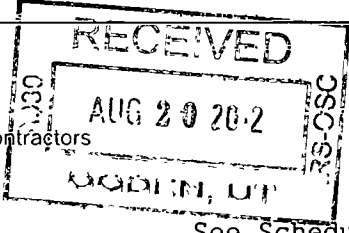

In 2011, Red Eagle Soaring Native Youth Theatre successfully accomplished its annual cycle of three programs: the Touring Spring Play; SIYAP, the two-week summer performing arts camp; and the fall theatre workshop series. All of RES' programming is free to greater Seattle's urban Native youth, and every program concludes with at least one free public performance. In 2011 a total of 1,000 audience members attended Red Eagle Soaring's free public performances.

From January to June of 2011, Red Eagle Soaring recruited a cast of sixteen urban Native youth ages 11-19 to write, stage and perform a play about the experience of Native Americans in the justice system, including the local history of Chief Leschi. Under the guidance and direction of two theatre teaching artists, the sixteen Native youth met weekly for five months to write, read and cast, block, rehearse, and stage a fully realized original play, performed first on Sunday, June 12th at Seattle's Rainier Valley Cultural Center, and then on tour to Browning, Montana in July, 2011 for a free public performance during the 60th Annual North American Indian Days Pow Wow.

Red Eagle Soaring held its 13th annual SIYAP (Seattle Indian Youth Arts and Performance) from August 8-19, 2011 at Daybreak Star Indian Cultural Center. Fifty urban Native youth ages 11-19 from throughout greater Seattle met with five teaching artists and twenty community volunteer mentors from 10am to 4pm daily, for ten days of work-shopping in playwriting, dramatic improvisation, musical

composition, stage costume and makeup, visual arts, and theatre skills. At the conclusion of the two weeks, the youth performed an original comedic musical play (Zombie Pow Wow) for a community audience at Daybreak Star Indian Cultural Center.

Red Eagle Soaring held its annual ten-week fall theatre skills workshop series, attended by seventeen urban Native youth ages 11-19. The youth spent the fall learning improv, voice projection, play-writing, and stage basics, and showcased their skills with Reclaiming Our Values, an original musical play written and performed by the youth. The workshop series concluded with two free public performances of Reclaiming Our Values at Daybreak Star Indian Cultural Center.
