4a (Code) (Expenses \$ 133,252 including grants of \$ 0) (Revenue \$ 0) The Breastfeeding Peer Counseling program offers peer counseling services to pregnant and postpartum women in the WIC program. Peer Counselors are matched with women in the last two months of their pregnancy and continue providing breastfeeding support for up to a year after the birth of the baby. They provide basic breastfeeding information through classes, clinic visits, phone contact and home visits. The Breastfeeding Peer Counseling Program is a collaborative program with Public Health - Seattle & King County.

4b (Code) (Expenses \$ 81,902 including grants of \$ 0) (Revenue \$ 0) Birth Doula Services provide support to women and their families before, during and immediately after the birth of their baby. Doulas provide information and education about healthy pregnancy and birth, breastfeeding and early parenting, physical and emotional support throughout the entire labor and delivery, breastfeeding support and parent coaching in the first 6 weeks after the arrival of the newborn. We served 168 clients in 2011.

4c (Code) (Expenses \$ 434,559 including grants of \$ 0) (Revenue \$ 0) White Center Early Learning Initiative (WCELI) provides a community-based, intensive home visiting service to women and families. Outreach doulas - who are of and from the communities they serve - are matched with women in the early part of their pregnancies and provide support for two years following the birth of their babies. Services include birth doula services, participation in the Promoting First Relationships parent/infant attachment curriculum, and ongoing education around early brain and socio-emotional development of children. We served 54 clients in 2011.
