Since 1955, Providence Benedictine Nursing Center has been a model of excellence, innovation and best practices that include spiritual and emotional support in addition to physical care The center has been a pioneer in caring for the frail and elderly in a variety of settings, always emphasizing the importance of an environment in which their individuality and preferences are respected About 1000 patients and residents are served each year in the nursing center Traditionally, donated funds received by the Foundation are used for the operations of the nursing center and special projects For example, donations to the special equipment campaign "While You Were Sleeping" was used for the purchase of 10 special mattresses These mattresses have new technology using air cells and a pump to mimic the natural movement of our bodies which in turn helps to protect fragile skin We continue to research and purchase additional mattresses as needed This year a special grant was received to be used for unreimbursed expenses for patients on Medicaid The Foundation was able to meet the needs of two residents with unique, and extremely expensive, wheelchair requirements

The Child Development Center at Providence Benedictine Nursing Center has been serving young children and families since 1988 Accreditation by the National Association for the Education of Young Children makes P B N C 's Child Development Center one of the highest quality programs in the nation and the only accredited program in Marion County The children, nursing center residents, and assisted living residents have the opportunity to benefit from intergenerational socialization opportunities The CDC provides childcare for employees and families (including from the St Joseph Shelter) in the surrounding community of Mt Angel In 2011 the CDC began the work of replacing its play structure, as was required to maintain their national accreditation The structure and installation cost about \$22,000 of which the first installment was made in December 2011 from the Foundation funds

Although the filing of Form 990 provides insight into how Providence achieves its Mission, delivers its programs and stewards its finances, deciphering the information directly from Form 990 can be challenging. The following paragraphs provide further information about the process we use to determine compensation for top management, officers and key employees. Providence has a single fiduciary Board, with responsibility for financial oversight associated with fulfillment of the Providence Mission, developing system policies, protecting the assets entrusted to the organization and overseeing the strategic and operational affairs of Providence's legal entities. Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. Providence has a consistent compensation philosophy for all of its employees, including our senior executives. Salaries for senior executives are determined by the Providence Board's Human Resources Committee and approved by the full Board of Directors, none of whom is a Providence employee. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Base salaries for Providence executives are set at the median level of the market, as identified by the independent consultant and reviewed with the Human Resources Committee. Performance incentives allow executives to earn additional compensation if they achieve specific organizational and individual goals for furthering Providence operating principles - advancing the Providence Mission and core values, meeting benchmarks for charity care, achieving quality targets, delivering top-rated customer satisfaction, meeting employee satisfaction goals and reaching financial performance objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate practices for not-for-profit health care systems. The Board's process for executive compensation fully complies with IRS standards and mirrors the best practices recommended in the "Report to Congress and the Nonprofit Sector on Governance, Transparency, and Accountability" submitted to the Senate Finance Committee by the Panel on the Nonprofit Sector. The Foundation Executive Director is compensated by a related organization which uses a market based compensation program utilizing several independent third party compensation market surveys to establish pay ranges for the position. The related organization then establishes the individual rate of pay within the range based on relevant experience, skills and competencies. The rate offered to the Executive Director at the time of hire was determined through discussion between the Regional CEO, Regional Director of HR and the Administrative Director of HR. The ranges and rate of pay are reviewed on an annual basis by Regional HR.
