The first phase of the new campus was completed in the summer of 2011 on-time and on-budget and has the capacity for 600 students, faculty, and staff. Campus features include a library, academic and administrative offices, 5 classrooms and 4 computer labs.

University Support (including scholarships) - The University support program provides support for scholarships and university operations. Close to 40% of Ashesi's students are on financial aid, though most of the scholarships are provided through tuition revenue at the University; the Foundation provides funds for some student scholarships every year.
