THE RESOURCES EXPENSED BY THE CAMPAIGN WERE USED TO PROVIDE NEW AND UNDERUSED VACCINES AND THE MEANS TO DELIVER THESE VACCINES THROUGHOUT THE POOREST COUNTRIES IN THE WORLD. THROUGH ITS SUPPORT, BY THE END OF 2011, THE CAMPAIGN HAD HELPED PREVENT MORE THAN 5 MILLION FUTURE DEATHS THROUGH ROUTINE IMMUNIZATION AGAINST HEPATITIS B, HAEMOPHILUS INFLUENZAE TYPE B (HIB) AND PERTUSSIS (WHOOPING COUGH), AND ONE-OFF INVESTMENTS IN IMMUNIZATION AGAINST MEASLES, POLIO AND YELLOW FEVER. MANY MORE HAVE BEEN PROTECTED AGAINST DEBILITATING ILLNESS AND DISABILITY. BY THE END OF 2011, MORE THAN 325 MILLION ADDITIONAL CHILDREN HAVE BEEN IMMUNIZED WITH GAVI-FUNDED VACCINES.


