Scholarships - The Washington State Potato Foundation awarded scholarships for the 10th consecutive year. A total of 42 applicants applied for scholarship funds (up from last year by 20%) and 30 students were identified to receive awards (also up approx. 25%). Awards ranged from \$500-\$5,000.

Three of the aforementioned students received Ag Ambassador Awards (\$5,000 awards) and the Washington State Potato Foundation scholarship committee has been working closely with these students (via email contact) in an attempt to bring students forward for mentoring experiences.

4b (Code) (Expenses \$ 8,058. including grants of \$) (Revenue \$)

Grower Education - The WSPF offers a host of educational workshops, seminars, pesticide certifications, first aid trainings, field day, lectures, and workshops that benefit the 300 plus growers throughout Washington. Field Day features field tours highlighting the latest research developments in potato growing practices and pest management, as well as water and nutrient use efficiency trials of several new potato cultivars (new varieties) and a host of educational seminars. The WSPF supports this program by sponsoring the lunch for the 350+ folks who attend this half day seminar that is attended by growers throughout the region. This event has been taking place for over 45+ years and the WSPF has been a partner in supporting this event since 2000.

Industry Leadership Banquet - The WSPF Industry Leadership Banquet was hosted on January 26, 2011 at the Red Lion Inn located in Kennewick. Lynn Olsen Sr was recognized for over 50 years of service and leadership dedicated to the potato industry.

The event was the largest ever with nearly 320 guests. This event was held in conjunction with the Washington Potato Conference which took place at Three Rivers Convention Center. By offering these two events concurrently, we found that audiences appreciated the social and thematic nature of the award and event.
