In 2011 the program provided housing and services to 22 parents and 42 children. The families at Vine Maple Place arrive without the resources and skills required to achieve stability and self-sufficiency in their lives. We define our success by how well our families achieve self-sufficiency and their ability to obtain and move into stable permanent housing. Our services to homeless families include: 1. Transitional housing: 2-bedroom apartments where families live for up to 24 months. 2. Case Management: assisting each family with a Family Transition Plan that focuses on achieving permanent housing along with stable employment in living-wage jobs. 3. Life-Skills Training: to build self-sufficiency, including Financial Literacy, Employment and Education counseling, goal-setting, job readiness, parenting skills, time management, building healthy relationships in family and community. 4. Family Support Teams: car mechanics, childcare helpers, job-skills trainers, tutors, hair stylists, computer trainers, and more. Mentoring: trained mentors who encourage and work with the families. 5. Child Advocacy: Each child is assessed for age/grade appropriate development in behavior and academics. Deficiencies are addressed by providing services such as tutoring, counseling, therapeutic intervention and life skills training. Our goal is to provide a safe, nurturing environment where children can heal, grow and thrive. In 2011 we received calls representing 3,340 homeless parents and children seeking help and housing.
