The cost of producing these tapes has been capitalized and was \$153,597. During 1994, a video documenting the life and work of a Tlingit elder was produced and the related costs of \$26,723 were capitalized. During 2009, a carved helmet was purchased by the Institute for \$2,000 and was capitalized. During 2010, historic recordings, blanket art, a Haida doll, a carved mask and four paintings were purchased by the Institute for \$7,320 and capitalized. During 2011, 2 halibut hooks and a haida mat were purchased by the Institute for \$12,300 and capitalized. Sealaska Heritage Institute operates a Special Collections Research Center which houses more than 5,000 publications, approximately 35,000 photographic images, recordings, roughly 1,000 cultural objects, nearly 3,500 audiovisual and more than 1,500 linear feet of manuscript material that document the history, culture, heritage, and language of the Tlingit, Haida, and Tsimshian people of Southeast Alaska. Those collections are made available to the public for educational purposes and for use in educational programs.
