The Ballot Counting Committee oversees the counting of the votes, authenticates the ballots, tallies the votes and presents the outcome at the Annual Meeting.

The amounts reported on Line 4 represent 2011 Allocation of Patronage. Members are notified in writing of their allocation. Retirements are made at the discretion of the Board of Directors.
