1. Conduct leadership skill and communications capacity trainings, round-tables and gatherings for community-based organizations serving primarily the Latino communities in the Northern and Mid-Willamette Valley.
2. Conduct technical and computing capacity assessments of those organizations and their staffs.
3. Engage and educate funders and civic leaders about capacity issues affecting those and similarly-situated organizations.
4. Provide limited support to expand technical and communications capacity.
5. Conduct fundraising, building development and program develop activities to establish the CAPACES Leadership Institute.

B. Support grants:
