Funding of operating expenses of, or payments on behalf of, Providence Child Center Providence Child Center provides services for children with disabilities Funds raised by the Foundation were used to support the following programs The Specialty Pediatric Medical and Dental Clinic has scheduled 360 appointments for the Center for Medically Fragile Children by Dental, GI, Neuro, Ortho and Vision specialists Since September of 2011, 125 outpatients have been seen in the Dental Clinic Beginning in October, a GI clinic for children with autism spectrum disorders has been available Also 80 assessments and 800 outpatient treatments/sessions have occurred through the augmentative communication lab Dental outreach programs for children with special needs have been identified as vitally important and underserved, especially in rural areas of the state Work has begun to identify partners to help reach out to underserved families Augmentative Communication Therapy has been highlighted through several special events and through increased media exposure to this therapy modality Children are learning to better express their needs and parents are finding ways to better assess their children's wants and needs The importance of aquatic therapy has been highlighted through several special events and supported through the receipt of several grants Raising the awareness of the value of aquatic therapy for children with special needs has been a focus for PCC in 2011 The Center plays a unique role in educating the community about the benefits of this therapy for children who are so vulnerable The Swindells Resource Center continues to reach out to families, especially in underserved areas of the state With centers in Medford, Newport, Hood River, Salem and Portland, the Swindells staff continues to provide resource materials, parenting classes and information to families with special needs children

The following paragraphs provide further information about the process we use to determine compensation for top management, officers and key employees. Providence has a single fiduciary Board, with responsibility for financial oversight associated with fulfillment of the Providence Mission, developing system policies, protecting the assets entrusted to the organization and overseeing the strategic and operational affairs of Providence's legal entities. Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. Providence has a consistent compensation philosophy for all of its employees, including our senior executives. Salaries for senior executives are determined by the Providence Board's Human Resources Committee and approved by the full Board of Directors, none of whom is a Providence employee. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Base salaries for Providence executives are set at the median level of the market, as identified by the independent consultant and reviewed with the Human Resources Committee. Performance incentives allow executives to earn additional compensation if they achieve specific organizational and individual goals for furthering Providence operating principles - advancing the Providence Mission and core values, meeting benchmarks for charity care, achieving quality targets, delivering top-rated customer satisfaction, meeting employee satisfaction goals and reaching financial performance objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate practices for not-for-profit health care systems. The Board's process for executive compensation fully complies with IRS standards and mirrors the best practices recommended in the "Report to Congress and the Nonprofit Sector on Governance, Transparency, and Accountability" submitted to the Senate Finance Committee by the Panel on the Nonprofit Sector. The Foundation Executive Director is compensated by a related organization which uses a market based compensation program utilizing several independent third party compensation market surveys to establish pay ranges for the position. The related organization then establishes the individual rate of pay within the range based on relevant experience, skills and competencies. The rate offered to the Executive Director at the time of hire was determined through discussion between the Regional CEO, Regional Director of HR and the Administrative Director of HR. The ranges and rate of pay are reviewed on an annual basis by Regional HR.
