Through our Leadership Development Program we train people to be community organizers. Our Activist Mobilizing for Power (AMP) conference, formerly Community Strategic Training Initiative, brings together over 400 participants across the country. Western Institute for Leadership Development (WILD) is a year-long intensive training program for emerging organizers and activists from Alaska, Washington, Oregon, Idaho, Montana and Wyoming. Through retreats and one-on-one mentoring, participants develop critical skills and lasting relationships with a network of colleagues that crosses constituencies, issues and geography. Since 1994, over 150 organizers have graduated from WILD and are now directing programs and organizations across the country.

4b (Code:) (Expenses \$ 335,375 including grants of \$ 146,000) (Revenue \$ 56,841)

Our Building Political Power Program believes that by organizing members as voters, underserved and marginalized communities can move from being legislated about to becoming equal partners and leaders in governing and community structures, shaping the policies that affect their lives. The centerpiece of the program is our Voter Organizing Training and Empowerment (VOTE) Project. We work with 14 groups to boost their people capacity, increasing the number of volunteers, members and leaders. Through year-round organizing and advocacy, participants in VOTE push for progressive policy changes in their communities and have won policies that protect LGBTQ people from discrimination, help prevent foreclosure, and increase state minimum wage.

4c (Code:) (Expenses \$ 354,252 including grants of \$ 178,600) (Revenue \$ 477,924)

The Gender Justice Program addresses sexism, heterosexism, transgender oppression, reproductive justice, and family security in the context of racial and economic justice. We develop tools, resources and analysis and provide training and organizational support to help groups and their constituencies fight conservative attacks and promote progressive policies. Our Gender Justice Program consists of Uniting Communities and Strong Families Northwest. We work with organizations based in communities of color to be more inclusive of their members who are LGBTQ, and be able to take a public stand for LGBTQ equality through Uniting Communities. Strong Families Northwest is part of a national initiative to shift the way we define family and to change the way policies affect most families.
