IN 2007, THE ORGANIZATION BEGAN TO DISPOSE OF ITS MEDICAL CLINICS, AND CONTINUED DISPOSING OF CLINICS AND WINDING UP OPERATIONS THROUGH 2010. DURING 2011, THE ORGANIZATION HAD NO ACTIVITY, AND FORM 990-N WAS ORIGINALLY FILED. IT HAS SINCE COME TO LIGHT THAT THE ORGANIZATION'S STATUS CHANGED FROM PUBLIC CHARITY TO PRIVATE FOUNDATION IN 2011 WHEN NO CLINIC OPERATIONS AND NO WINDING UP ACTIVITIES WERE BEING CONDUCTED. THIS AMENDED RETURN IS BEING SUBMITTED TO COMPLY WITH THE REQUIREMENTS OF A PRIVATE FOUNDATION BY FILING FORM 990-PF.
