Meals serving 150 individuals are provided 3 times each week to the residents of a major housing project and those in the local area. Then fifty meals are distributed through out the warehouse district to those living in the streets.

Life sustaining services for those living in the streets. Three times each week we travel through the Old Town and Warehouse district of Portland caring for the basic needs of the homeless. By providing blankets, first aid and items necessary for surviving street life, we build sufficient trust with the mentally ill and disenfranchised to begin social service intervention for permanently changing their lives.
