Part III - What is the organization's primary exempt purpose? - Statement 1

To enhance the health and well-being of individuals with physical, mental or emotional limitations through participation in community-based therapeutic gardening programs.

Part III, line 28 - Statement 2

During 2011, Garden Partners explored the viability of creating a multi-use urban farm, integrating therapeutic aspects of gardening, food production and community access to healthy food. Our goal was to reach a larger number of individuals through this program.

This type of project, while generating much public interest, will require many collaborative community players. Garden Partners was able to successfully transition all of our existing programs which were supported by our employees in 2010, to being fiscally managed by each facility in 2011.
