**SAFETY & SENTENCING PROGRAM** This program develops approaches to public safety that more effectively build safe communities, are fiscally responsible, and reduce our reliance on incarceration. PSJ has historically worked to challenge the way youth are treated as adults within Oregon's criminal justice system, and in 2011 this work culminated in the passage of House Bill 2707, the Safe Kids, Safer Communities Bill. We drafted this bill because youth charged as adults can stay up to a year in adult jail awaiting trial— often in isolation to "protect" them from the adult population, & without access to youth appropriate services. The new law changes the default placement of youth charged as adults to a juvenile detention center rather than adult jail. We also released "Misguided Measures: The Outcomes and Impacts of Measure 11 on Oregon's Youth". This report was co-produced with the Campaign for Youth Justice and is the most comprehensive report done on the way youth are impacted by Oregon's harsh mandatory minimum law. We reviewed the data from every youth indictment on a Measure 11 offense since the law's implementation in 1995 (over 3,200 cases). We have received tremendous feedback from system stakeholders around Oregon. The report was released one week after the Governor appointed a high-profile sentencing commission to overhaul our criminal sentencing laws. "Misguided Measures" is sure to influence the commission's work.

**MEMBER ENGAGEMENT & PUBLIC EDUCATION** The focus of this program's work is to position PSJ as a leader for facts and analysis on the need for reforming the criminal justice system and increase our member involvement in that reform. Three issues of our newsletter, Justice Matters, were sent to 3,000 people with news, issue analysis and resource information. In 2011, we covered such topics as justice reinvestment, successful "smart on crime" reforms that are working, and how PSJ is at the forefront of challenging the false choice between victims' needs and corrections reform. We sent out 12 electronic action alerts to nearly 2,300 members of our Action Alert Network encouraging them to become more involved. Nearly 200 individuals performed 1500 hours of volunteer service with PSJ. We had 32,190 visitors to our website and our Facebook page was "liked" by 764 people. There were 2425 radio spots mentioning PSJ, and 54 newspaper articles mentioned or quoted PSJ. Seventeen member letters to the editor were published and a member and a staff person had guest columns published. There were 15 TV and other media posts that mentioned PSJ.

**CRIME SURVIVOR PROGRAM** In 2011, Oregon faced a huge budget shortfall for the upcoming biennium a \$3.5 billion gap. This meant that virtually every program receiving general fund money faced deep cuts. The Oregon Domestic & Sexual Violence Services Fund faced a 24% cut. This budget crisis provided an opportunity for PSJ to move many victim advocates to support a Justice Reinvestment framework to cut corrections costs and reinvest some of the savings into victims' services. We organized testimony by individual crime survivors and victim advocacy organizations in support of Justice Reinvestment for the Oregon Ways & Means Committee and for community town hall budget hearings. Testimony called for sentencing reform and reinvesting savings into victims' services, law enforcement, drug & alcohol treatment, & re-entry programs. We facilitated victim advocate meetings with legislators and editorial boards of major newspapers to support Justice Reinvestment. We held a press conference to highlight survivor and victim advocate support of sentencing reform. Also, PSJ helped organize a DV/SA Awareness Day, with almost 100 service providers. In Dec 2011, PSJ released "Moving Beyond Sides. The Power and Potential of a New Public Safety Policy Paradigm". This concept paper describes and promotes a holistic approach to criminal justice policy that works with everyone most impacted, and moves beyond the oppositional silos of victim advocacy & prison downsizing.
