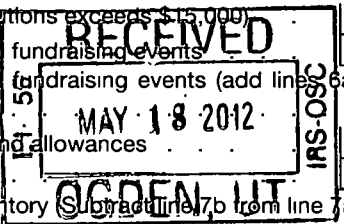

Multicultural Education

Harambee works with Africans and other members of our board of directors to develop sister school partnerships in schools and communities in the US and Africa, connecting students and teachers in the communities they know there with students and teachers in the communities they know here. Harambee Centre has developed sister school partnerships in Kenya and Uganda.

African Community Development

Chwele, Kenya: Funding for a community center that provides additional preventative health care services and training, and micro-credit small business loans to women and youth that provides self-supporting income for their families.

Matale, Uganda: Completion of a science lab at a secondary school; the first class sat for their national exams (Uganda Certificate of Education) using the lab facilities. Broke ground for the construction of a Girl's Dormitory. St. Andrews has about 420 students and 32 staff members all of whom use the Science Lab.

Tanzania: Funding for building a training center for the Naisosian Sewing Project.
