NOTE 1 -NATURE OF ACTIVITIES AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Organization

Lincoln County Foundation was established in the 1960s to hold in trust, gifts and bequests, invest the funds and disburse per the specific provisions of the giver. Funds have gone for civic, educational, and charitable purposes promoting the welfare and well-being of the people, particularly the youth of Lincoln County. The Foundation is supported through public and private contributions.

Basis of Accounting and Presentation

The accounts of the Foundation are maintained on the accrual basis of accounting. Accordingly, revenues are recognized when earned and expenses are recognized when incurred. The Foundation is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets, and permanently restricted net assets.

Cash and Cash Equivalents

For purposes of the statement of cash flows, the Foundation considers all unrestricted highly liquid investments with an initial maturity of three months or less to be cash equivalents.

Investments

The Foundation carries its investments at market value. Accordingly, unrealized gains or losses are based on the market value of assets at year end.

Contributions

All donor-restricted contributions are reported as increases in temporarily or permanently restricted net assets depending on the nature of the restriction. When a restriction expires (that is, when a stipulated time restriction ends or purpose restriction is accomplished), temporarily restricted are reclassified to unrestricted and reported in the statement of activities as released from restrictions.

Scholarships

Scholarships are derived from available income and principal in accordance with designations by the donors and as approved by the Board of Directors. Scholarships are recognized and recorded on the date they are approved.

Grants

Grants come from available income and principal as approved by the Board of Directors and are recorded on the date the grant is approved.

Continued

Endowment Funds

The Foundation's permanently restricted net assets consist of an individual fund established for a variety of purposes. As required by generally accepted accounting principles, net assets associated with endowment funds are classified and reported based on the existence or absences of donor-imposed restrictions.

The Board of Directors of the Foundation has interpreted the Uniform Prudent Management of Institutional Funds Act (UPMIFA) as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor stipulations to the contrary. As a result of this interpretation, the Foundation classifies as permanently restricted net assets (a) the original value of gifts donated to the permanent endowment, (b) the original value of subsequent gifts to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund. The remaining portion of the donor-restricted endowment fund that is not classified in permanently restricted net assets is classified in temporarily restricted to appropriate for expenditures by the Foundation. In accordance with UPMIFA, the Foundation considers the following factors in making a determination to appropriate or accumulate donor-restricted endowment funds: (1) the duration and preservation of the various funds, (2) the purposes of the donor-restricted endowment funds, (3) general economic conditions, (4) the possible effect of inflation and deflation, (5) the expected total return from income and the appreciation of investments, (6) other resources of the Foundation, and (7) the Foundation's investment policies.

Investment Return Objectives, Risk Parameters and Strategies. The Foundation has adopted investment policies approved by the Board of Directors, for endowment assets that attempt to provide a predictable stream of funding to programs supported by its endowment funds while also maintaining the purchasing power of those endowment assets over the long-term. Accordingly, the investment process seeks to achieve an after-cost total real rate of return which exceeds the annual distribution with acceptable levels of risk. Endowment assets are invested in a well diversified asset mix, which includes equity and debt securities, that is intended to result in a consistent inflation-protected rate of return. The Foundation has not specified an annual rate of return. Investment risk is measured in terms of the total endowment fund; investment assets and strategies are managed to not expose the fund to unacceptable levels of risk.

Spending Policy. The Foundation has adopted a spending policy to determine the annual amount available for distribution from funds held as permanent endowment. In establishing this policy, the Foundation considered the long-term expected return on its investment assets, the nature and duration of the endowment funds, which must be maintained in perpetuity because of donor-restrictions, and the possible effects of inflation. The Foundation expects the current spending policy to allow its endowment funds to grow at a nominal average rate annually. This is consistent with the Foundation's objective to maintain the purchasing power of the endowment assets as well as to provide additional real growth through new gifts and investment return.

Fair Value Measurements

Under SFAS No. 157 there is a three-level hierarchy for disclosure of investments recorded at fair value. Level I represents quoted prices available in active markets. Types of investments would include listed equities and derivatives. Level II consists of pricing inputs observable for the investments, either directly or indirectly. Fair value is determined through the use of models or other valuation methodologies. Investments generally in this category are corporate bonds, loans, less liquid and restricted equity securities and certain over-the-counter derivatives. Level III are pricing inputs unobservable and include situations where there is little market activity. Investments in this category include general and limited partnership interests in corporate private equity and real estate funds.

The Foundation's policy is to be diversified in low risk income, growth and income, and growth mutual funds. Investment securities are exposed to various risks, such as interest rate, market and credit. The diversification of the Foundation's invested assets among these various asset classes should mitigate the impact of dramatic change on any one asset class. All investments are through a brokerage with SIPC coverage.

NOTE 3- ACCOUNTS RECEIVABLE

Receivables are reported at the amount anticipated to be collected at year end. The direct write-off method is utilized.
