 2-1-1 California: Trained Information & Referral specialists assess callers needs connect people of all income levels and language and cultural backgrounds to community services such as rent and mortgage assistance, food and shelter, healthcare, job training, transportation, childcare, and senior care. 2-1-1 services have been important gateways for enrolling low- and moderate-income families in health insurance and other important programs. In emergencies and disasters, 2-1-1 also plays a critical role by helping officials provide accurate information to the public, such as evacuation, shelter, food, medical and recovery information. Currently, 2-1-1 service is available to 93% of the state's residents in 28 of 58 counties. UWCA's goals are to strengthen and expand the 2-1-1 network to provide service to those Californians currently unserved, mostly residing in rural areas, and to streamline and improve connectivity among all 2-1-1 information and referral providers.

 Health & Capacity Building: United Ways of California works with local United Ways and other partners to expand health coverage and access to care for all children. Children with health insurance are more likely to get the care they need to ensure healthy development, including preventive care, immunizations to prevent diseases, and basic check-ups with primary care physicians. Providing children with health coverage and preventive care prevents more serious and costly health problems. Ensuring children have access to health coverage and preventive care gives them the best chances to develop and to achieve in school, and also can save taxpayers and employers billions of dollars reducing costs and by lowering parents' absenteeism and the resulting loss of productivity. United Ways of California supports collaborative efforts to build capacity and improve effectiveness of California United Ways, through knowledge sharing, training, convening members for planning and program development, and supporting resource development at the state and regional levels.
